In the meantime, counsel for Plaintiffs will file a report by close of business on March 20, 2019 set–ting forth what information they would like Defendants' monthly status reports to contain. The Court also held a final pretrial conference on Plaintiffs' individual personal injury claims, which are set for trial on April 15, 2019. Counsel advised that the parties have reached a settlement on all of the Plaintiffs' individual personal injury claims. Accordingly, the April 15, 2019 trial in this matter is VACATED and the settlement conference scheduled with the Magistrate Judge for March 19, 2019 is VACATED. All pending motions, if any, are now DENIED AS MOOT and all previously ordered dates relating to discovery, filings, schedules, conferences, and trial, if any, are VACATED.
