ORDER

Having duly considered the Unopposed Motion Pursuant to the Rule 67 of the Federal Rules of Civil Procedure to Deposit Cy Pres Fund in the Court's Registry, Determine Its Next Best Use and to Order the Class Administrator to Report to the Court Regarding Final Disposition of Any and All Funds from Unclaimed/Non-Negotiated Checks Made Out to Authorized Claimants, and Memorandum in Support Thereof,

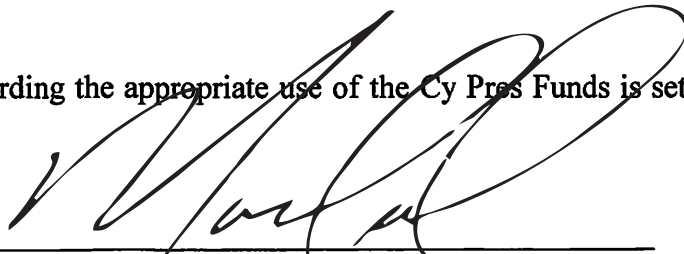
IT IS HEREBY ORDERED that:

1. The Clerk of this Court is ORDERED to permit the deposit into the registry of the Court those funds remaining in the account of the N.O. Strip Search Settlement Fund account at the Capital One Bank, New Orleans, Louisiana. This fund is to be considered as a Cy Pres Fund, to be disbursed upon further Order of this Court, to the next best use, considering the objects and goals of the Class in improving the conditions and treatment of individuals in the custody of the Orleans Parish Sheriff.

2. The Court Appointed Claims Administrator, i.e., Analytics, Inc., President Richard

Simmons, 18750 Lake Drive East, Chanhassen, MN 55317, Analytics, Inc., President Richard Simmons, 18732 Lake Drive East, Chanhassen, MN 55317 and Richard Simmons, Manager, Analytics Consultants, LLC, located at 18675 Lake Drive East, Chanhassen, MN 55317-9383 are each and every one, hereby ORDERED to prepare and file with the Court by the 17th day of July, 2017, a final report documenting the escheating of each and all unclaimed/non-negotiated checks made out to Authorized Claimants and the closing of the bank account(s) related to this litigation. This report shall be filed in a sealed envelope, under the terms of the Protective Order previously issued by this Court, Doc. 179, to prevent disclosure of personal and confidential identifying information, including last known home address, date of birth and social security numbers of the class members, with copies to counsel for the parties, also pursuant to Protective Order of the Court as previously provided for by Order, Doc. 179. This report shall also include information identifying the state of unclaimed property funds to which each Authorized Claimant's funds was escheated and the date said funds were escheated. In addition, the report shall also provide information regarding the name and account number(s) of the bank from which said funds were escheated and documents confirming the closure of said account(s) and the date of said closure.

3. A status conference regarding the appropriate use of the Cy Pres Funds is set for the 31st day of July, 2017 at 2:00 p.m.
