9 Before the Court are the State of Washington's Unopposed Motion to
10 Consolidate for Pretrial Proceedings, ECF No. 7, and the parties' Joint Motion to
11 Expedite and Set Briefing Schedule on Motions for Preliminary Injunction, ECF
12 No. 6. The State asks that two related cases be consolidated for scheduling and
13 other pretrial purposes, *State of Washington v. Azar, et al.*, No. 1:19-cv-3040-
14 SAB, and *National Family Planning & Reproductive Health Ass'n, et al. v. Azar,*
15 *et al.*, No. 1:19-cv-03045-SAB. It indicates that no party opposes consolidation.
16 The Court finds that the interest of judicial convenience outweighs any potential
17 for delay, confusion and prejudice. As such, good cause exists to grant the motion
18 and to set a briefing schedule for the anticipate Motions for Preliminary
19 Injunction.

20 Accordingly, **IT IS HEREBY ORDERED:**

21 1. The State of Washington's Unopposed Motion to Consolidate for
22 Pretrial Proceedings, ECF No. 7, is **GRANTED**.

23 2. All future pleadings shall be filed under Case No. 1:19-cv-03040-
24 SAB, unless the Court directs otherwise. Case No. 1:19-cv-03045-SAB shall be
25 administratively closed.

26 3. The parties' Joint Motion to Expedite and Set Briefing Schedule on
27 Motions for Preliminary Injunction, [1:19-cv-03040-SAB, ECF No. 6], [1:19-cv-
28 3045-SAB, ECF No. 17] is **GRANTED**.

1 4. The Court imposes the following briefing schedule and page
2 limitation:

- 3 a. **March 22, 2019:** Plaintiffs in both cases will file their respective
4 motions for preliminary injunction of no more than 45 pages each.
5 b. **April 12, 2019:** Defendants will file their opposition to the
6 motions in the form of a consolidated response of no more than 75
7 pages.
8 c. **April 19, 2019:** Plaintiffs will each file a reply brief of no more
9 than 30 pages each.

10 5. The hearing on Plaintiffs' Motions for Preliminary Injunction is set
11 for **April 25, 2019, at 10:00 a.m.**, in Yakima, Washington.

12 **IT IS SO ORDERED.** The Clerk of Court is directed to enter this Order
13 and forward copies to counsel.
