The Court called to the attention of counsel that recent decisions of the 5th Circuit require that entire process of desegregation must be completed by the Fall of 1967 and that at least four grades must be desegregated at mid-term of January, 1966. Copies of said Order (Decree) were delivered by the Clerk to counsel for each side and counsel for Defendants noted on original of said order his acceptance of service, waiver of citation & reservation of all rights.
