1 Plaintiffs' Motion for Class Certification came on regularly for hearing on
2 April 12, 2018 in Courtroom 9D of the above-entitled Court.

3 After full consideration of the evidence, the oral arguments of each party,
4 and the authorities submitted by counsel, the Court finds this action is maintainable
5 as a class action under Federal Rule of Civil Procedure Rule 23(a), 23(b)(1), and
6 23(b)(2). Accordingly, the Court **GRANTS** Plaintiffs' Motion and certifies the
7 following classes:

- 8 • **Plaintiff Class:** All people who are now, or in the future will be,
9 incarcerated in the Santa Barbara County Jail system.
- 10 • **Plaintiff Subclass (the "Disabilities Subclass"):** All people who are
11 now, or in the future will be, incarcerated in the Santa Barbara County
12 Jail system and who are qualified individuals with disabilities, as that
13 term is defined in the Americans with Disabilities Act (ADA), 42 U.S.C.
14 §12102, the Rehabilitation Act, 29 U.S.C. § 705(9)(B), and California
15 Government Code § 12926(j) and (m).

16 The Court hereby certifies Plaintiffs CLAY MURRAY, SHAREEN
17 WINKLE, and MARIA TRACY as representatives of the Plaintiff Class and
18 Disabilities Subclass and appoints Disability Rights California, Prison Law Office,
19 and King & Spalding LLP as Class Counsel.

20 The Court orders the parties, pursuant to Rule 23(c)(2)(A), to confer and
21 submit a proposed notice to the Plaintiff Class and Disabilities Subclass, and the
22 method of distribution of that notice, within 30 days of the Order certifying the
23 Plaintiff Class and Disabilities Subclass.

24 IT IS SO ORDERED.
