| 04/23/2020 | Order filed.   | TO THE SUPERIOR COURT OF LOS ANGELES COUNTY: Pursuant to the Supreme Court order of April 22, 2020 and good cause appearing therefor, real parties in interest are ordered to show cause in a return before the superior court addressing whether juveniles detained in Los Angeles County juvenile facilities are being denied due process under the Fourteenth Amendment by being held in conditions that could subject them to contracting the COVID-19 virus and, if so, what remedies can be lawfully ordered. The Los Angeles Superior Court is ordered to expedite this order to show cause, and any hearings shall be scheduled as soon as practicable. The clerk of this court is directed to send the Los Angeles Superior Court copies of the petition, the April 16, 2020 Supreme Court letter to counsel, the informal response and reply filed in the Supreme Court, the April 22, 2020 Supreme Court order, and this order to show cause. Upon receipt of these documents, the superior court is directed to cause the petition to be filed, to set a date for the filing of a return, and to conduct further proceedings.
