7 **ORDER**

8 WHEREAS, this matter came on for consideration by the Court upon
9 Verified Emergency Petition Seeking Extraordinary Relief for the 2020 Primary
10 Election and Presidential Primary Election; Response in Intervention of the
11 Republican Party, County Clerks and Legislators; Response of the Governor of
12 New Mexico; Response of the New Mexico Legislative Council; Response of the
13 Democratic Party of New Mexico, Response of the Libertarian Party of New
14 Mexico; Supplemental Brief of Petitioners; Supplemental Brief of Intervenors;
15 Amicus Brief of the League of Women Voters, Common Cause, American Civil
16 Liberties Union of New Mexico, Disability Rights New Mexico, Native American
17 Voters Alliance Education Project, and Santa Domingo Pueblo; Amicus Brief of
18 Professors of the University of New Mexico School of Law; Amicus Brief of
19 Voters; Amicus Brief of the Navajo Nation; the oral argument of the parties on
20 April 14, 2020, and Respondent Secretary of State's Notice for Clarification in
21 Supreme Court's Final Order;

1 WHEREAS, this Court takes judicial notice of the public health emergency
2 declared by the Governor of New Mexico on March 11, 2020, and the Executive
3 Orders and Public Health Orders issued to date by the Governor and the Secretary
4 of the New Mexico Department of Health to address the public health emergency;

5 WHEREAS, the mailing of an absentee ballot by a county clerk under
6 NMSA, 1978, Section 1-6-5(F) (2019), “shall not be delivered by the county clerk
7 to any person other than the applicant for the ballot,” but the Election Code does
8 not prohibit the Secretary of State and county clerks from mailing applications for
9 absentee ballots to New Mexico registered voters;

10 WHEREAS, there is no dispute in this proceeding that in-person voting
11 poses a substantial health risk to New Mexicans and that absentee voting is,
12 therefore, the preferred method for voting during the current public health
13 emergency; and

14 WHEREAS, in light of the foregoing, and the Court having considered the
15 pleadings and arguments of the parties and being sufficiently advised, Chief
16 Justice Judith K. Nakamura, Justice Barbara J. Vigil, Justice Michael E. Vigil,
17 Justice Richard C. Bosson, sitting by designation, and Justice Edward L. Chavez,
18 sitting by designation, concurring;

19 NOW, THEREFORE, IT IS ORDERED that a writ of mandamus shall issue

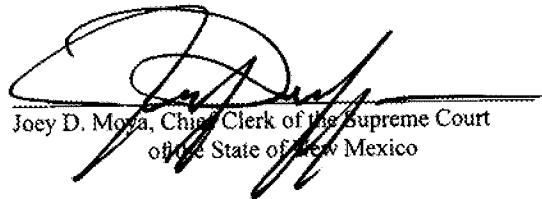
1 directing the Secretary of State and County Clerks of New Mexico to mail an
2 application for an absentee ballot to every major party registered voter in New
3 Mexico who has not already submitted an absentee ballot application for the 2020
4 primary election and conduct in-person voting for the upcoming primary election,
5 whether on election day or during early voting, in compliance with the Election
6 Code and all applicable Executive Orders and Public Health Orders issued by the
7 Governor of New Mexico and Secretary of the New Mexico Department of Health;
8 and

9 IT IS FURTHER ORDERED that this Court shall issue an opinion at a later
10 date to further explain its ruling in this case.

IT IS SO ORDERED.
