20-0729 THE STATE OF TEXAS v. CHRIS HOLLINS, IN HIS OFFICIAL CAPACITY AS HARRIS COUNTY CLERK; from Harris County; 14th Court of Appeals District (14-20-00627-CV, ___ SW3d ___, 09-18-20)

The Court grants the petition for review, reverses the court of appeals' judgment, and remands the case to the trial court for entry of a temporary injunction.
