To support their assertions of both associational standing and irreparable harm, Plaintiffs rely on injuries that three individual members of Plaintiff Coalition for Humane Immigration Rights ("CHIR") will suffer if the Final Rule goes into effect. Pls.' Mot. for Stay, ECF No. 19 [hereinafter Pls.' Mot.], Pls.' Mem., ECF No. 19-10, at 21, 41. Plaintiffs identify these three members by only their initials: T.F.F., M.S.R., and Y.M.G.R. Id.; see also Pls.' Mot., Salas Decl., ECF No. 19-8, paras. 58-59, 61. It is well settled in this Circuit that "it is not enough" for a plaintiff claiming associational standing "to aver that unidentified members have been injured." <i>Chamber of Commerce v. EPA</i> , 642 F.3d 192, 199 (D.C. Cir. 2011). "Rather, the [plaintiff] must specifically identify members who have suffered the requisite harm." Id. at 200-01 (internal quotation marks omitted). Although the court has not found any case from the D.C. Circuit addressing whether it is adequate to identify a member by only his or her initials to support associational standing, the court is dubious that such an approach is proper as it denies Defendants the opportunity to test the member's assertion of harm. Cf. <i>Nw. Immigrant Rts. Project v. USCIS</i> , No. 19-3283, 2020 WL 5995206, at *9 (D.D.C. Oct. 8, 2020) (rejecting associational standing where the complete omission of a member's identity "deprived Defendants of the ability to dispute Plaintiffs' claim of associational standing"). In view of this authority, if Plaintiffs wish

		to rely on the harms alleged by the three CHIR members to establish associational standing and irreparable harm, they shall disclose their identities to Defendants by no later than noon on January 13, 2021. Plaintiffs shall make such disclosure by filing a sealed version of the Salas Declaration that reflects the members' full names. Alternatively, if Plaintiffs believe that they can validly proceed by identifying their members by only their initials, then they shall make that argument in their reply brief.
