AGREED ORDER MODIFYING CONSENT DECREE

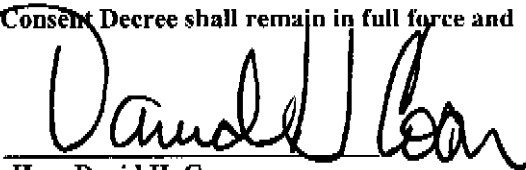
This matter having come before the Court on the Joint Motion of the CHA and the City of Chicago for Modification of the Consent Decree, the parties having taken some discovery and then having reached an agreement, and the Court being fully advised in the premises, IT IS HEREBY ORDERED THAT:

1. Paragraph VIII(B) of the August 30, 2000 Consent Decree is hereby amended by adding the following language to the end of the paragraph:

However, with respect to the redevelopment of Parcel 1 (*see* Appendix B to the Consent Decree) by the Holsten Development Corporation, the Community and Supportive Services program for that parcel will be jointly developed and administered by the Cabrini-Green LAC (or its affiliated development entity) and Holsten Development Corporation in accordance with ¶¶ 6(C), 6(D), 7(C), 7(D) and 11 and Addendum 2 of the Term Sheet (attached as Exhibit 1 hereto), which will be incorporated into the partnership development agreement to be executed by the development partners, including the Cabrini-Green LAC (or its affiliated development entity).

2. The remaining provisions of the August 30, 2000 Consent Decree shall remain in full force and effect.
