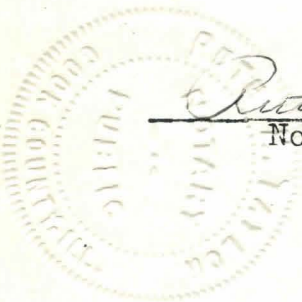

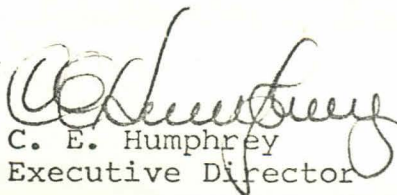

The formula established by the Court's Order of July 1, 1969, as applied to CHA's 1,500 dwelling unit allocation from HUD, requires that 1,300 units be located in the General Public Housing Area (GPHA) and permits 200 units to be located in the Limited Public Housing Area (LPHA).

Experience has shown that many sites, although apparently available at the time of initial identification, will not be available when development begins. For that reason CHA has included in this listing sites that will accommodate substantially more units than is required, when combined with previous listings, to produce 1,300 units in the GPHA.

With respect to the 200 dwelling units to be located in the LPHA, the City Council of the City of Chicago has approved sites in the LPHA that will produce in excess of 200 units. As development of the 1,300 units in the GPHA is undertaken, CHA intends to select sites for the 200 units in the LPHA from sites already approved by the City Council. Sites for the 200 units to be located in the LPHA are not included in the list filed herewith.
