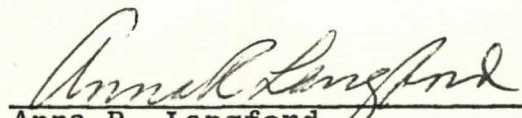

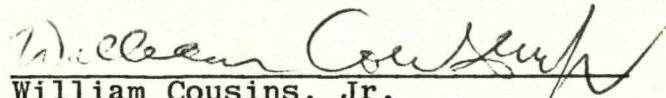
The undersigned, being first duly sworn,
on oath depose and state that:

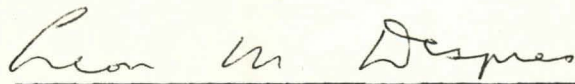
1. They are members of the City Council of

relevant allegations contained in the supplemental complaint.

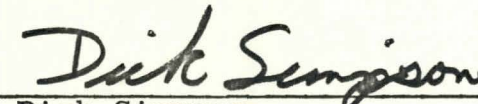
2. At the trial of the issues of the Supplemental Complaint the position taken by affiants supported that taken by the plaintiffs-appellees.

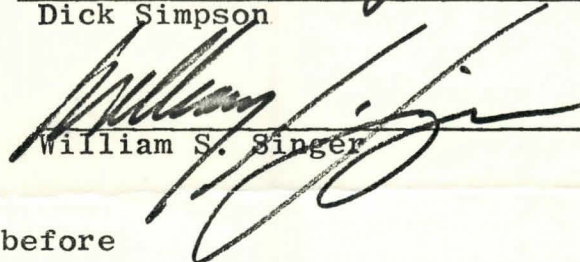

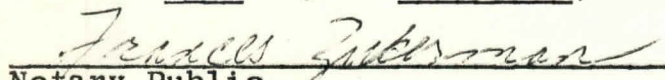
