The Chicago Housing Authority (the "CHA"), by and through its attorneys, respectively moves this Court for leave to file a surreply to Plaintiffs' Reply Brief In Support Of Motion To Modify CHA Judgment Order (the "Reply"), filed on July 28, 1997. support of the motion, the CHA states as follows:

1. On March 21, 1997, plaintiffs filed Motion To Modify CHA Judgement Order ("Motion"). The Motion was filed without an accompanying brief, and outlined in summary fashion the plaintiffs' proposed modification and the grounds justifying the proposed modification.

2. On June 25, 1997, the CHA and the Department of Housing and Urban Development ("HUD") filed briefs in response to the Motion. On July 28, 1997, plaintiffs filed the Reply. On August 6, 1997, HUD filed a motion for leave to file a surreply. On August 8, 1997, the Court granted HUD's motion.

3. Plaintiffs' Reply discusses several issues that were not raised in the Motion. The CHA could not have anticipated the additional arguments, and therefore should be granted permission to respond to the Reply.

WHEREFORE, the CHA respectfully requests leave to file a surreply, which surreply will be ready for filing with the Court by Tuesday, August 12, 1997, at the latest.
