APPEAL NOS. 98-1807 AND 98-2311 AND FOR STAY OF BRIEFING
OF RELATED APPEAL FILED AUGUST 24, 1998**

The Chicago Housing Authority ("CHA") has moved to expedite the argument and decision in Consolidated Appeal Nos. 98-1807 and 98-2311 and to stay briefing of the related third appeal that the CHA filed on August 24, 1998 from the District Court's Order of August 12, 1998 or, in the alternative, to expedite briefing in the August 24, 1998 appeal.

The Receiver does not object to the CHA's motion, as many of the issues raised by the third appeal have already been briefed in connection with the consolidated appeal and briefing of the issues raised by the third appeal would to some degree be duplicative. The Receiver notes, however, that there are significant factual and legal errors in the CHA's motion and description of the issues

raised by the third appeal. Those misstatements can be addressed when and if it becomes necessary to brief the third appeal.

The Receiver is interested in the prompt resolution of this matter, and wishes to follow the approach that the Court deems appropriate.

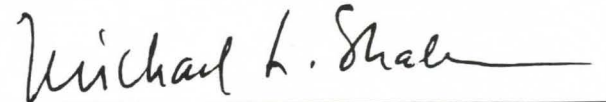
