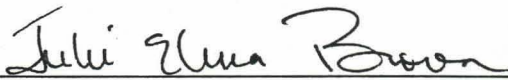
**RESPONSE OF GAUTREAUX PLAINTIFFS

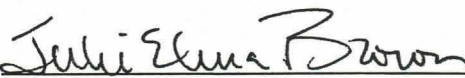
