**ORDER GRANTING PLAINTIFFS' MOTION FOR TEMPORARY
INJUNCTION**

Plaintiffs' Motion for a Temporary Injunction comes on for hearing on August 19, 2013. The Plaintiffs appeared by David Brown, Tiseme Zegeye, Martha M. Hardwick, and Roland Tague. All Defendants, represented by the office of Attorney General E. Scott Pruitt, appeared by Patrick R. Wyrick, Solicitor General, and Cara N. Rodriguez, Assistant Solicitor General. After reviewing the Petition, Plaintiffs' Motion for a Temporary Injunction and Additionally a Temporary Restraining Order ("Motion"), Plaintiffs' Memorandum of Law in Support of their Motion for a Temporary Injunction and Additionally a Temporary Restraining Order, Defendants' Response in Opposition to Plaintiffs' Motion for a Temporary Injunction and Additionally a Temporary Restraining Order, and Reply Memorandum of Law in Further Support of Plaintiffs' Motion for a Temporary Injunction, and having heard oral argument, the Court finds that the Motion is supported by good cause and should be granted.

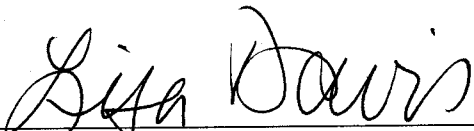
IT IS THEREFORE ORDERED, ADJUDGED AND DECREED THAT

IT IS SO ORDERED.

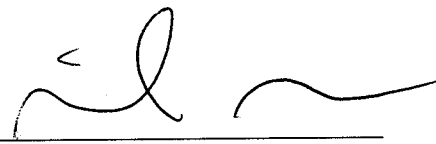

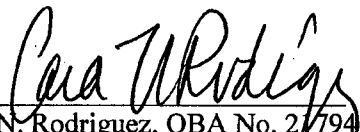

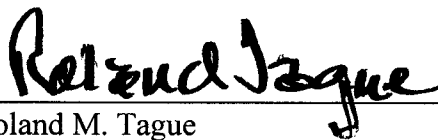
