By 3/3/06, defendant shall make a good faith settlement counter-proposal, responding to the proposal previously made by plaintiff. By 3/10/06, plaintiff shall respond to defendant's counter-proposal. By 3/20/06, each of the parties' attorneys shall submit independently, by way of e-mail addressed to the undersigned magistrate judge, an updated confidential settlement report. These reports shall briefly set forth the parties' settlement efforts to date, current evaluations of the case, views concerning future settlement negotiations and the overall prospects for settlement, and a specific recommendation regarding mediation and/or any other ADR method, together with an indication concerning who has been selected by the parties (preferably jointly) to serve as a mediator or other neutral in an ADR process. These reports need not be served upon opposing parties and shall not be filed with the Clerk's Office. Thereafter, the court may order the parties to participate in mediation or another ADR process.
