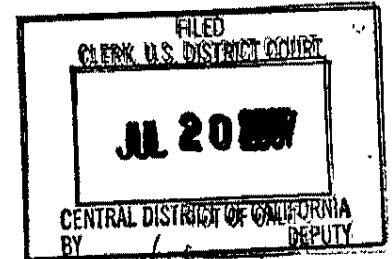

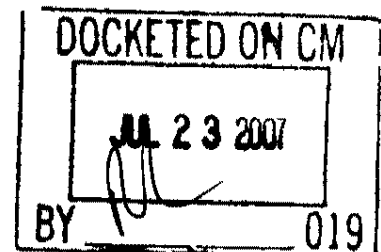

9 costs and attorneys' fees.

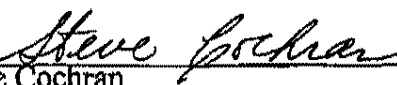

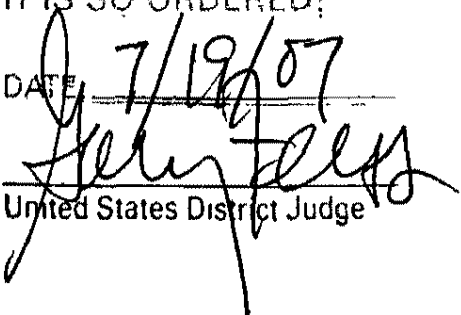

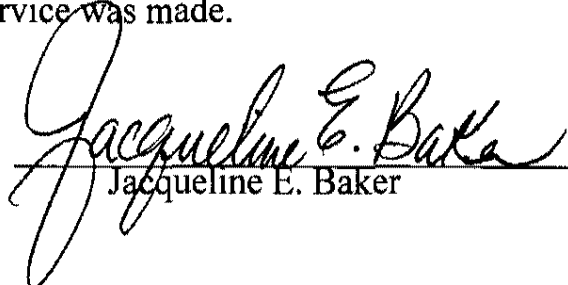
