SETTLEMENT AGREEMENT

Plaintiff Roberta Imogene Jones (“Jones”), defendant Grady County, Georgia (“Grady County”), and defendant J. William Bass, Sr. (“Judge Bass”), hereinafter collectively referred to as the “Parties,” hereby agree to settle and resolve all of the issues raised in the complaint filed in the above-styled action upon the following terms:

1. Pursuant to Rule 23 of the Federal Rules of Civil Procedure, the Parties will ask the Court to certify a class (the “Class”) that consists of each individual who meets the following criteria:

- a. the individual had a criminal case pending in the State Court of Grady County; and
- b. on or after September 24, 2011, Judge Bass entered an order in the individual’s criminal case that required the individual to pay Administrative Costs; and

- c. the individual paid some or all of the Administrative Costs ordered by Judge Bass.

At the same time that they ask the Court to certify the Class, the Parties will also ask the Court for preliminary approval of the terms of this settlement agreement (the "Agreement"). Assuming that the Court preliminarily approves the Agreement, the Parties shall proceed in accordance with the following paragraphs.

2. Following the certification of the Class and preliminary approval of the Agreement, Grady County will attempt to notify the members of the Class of the terms of the Agreement in the following manner:

- a. Grady County will publish the advertisement (the "Advertisement") attached as Exhibit A in the Cairo Messenger once a week for two weeks to begin within 30 days following the certification of the Class and preliminary approval of the Agreement;
- b. on or before the date on which the Advertisement is first published in the newspaper, Grady County will mail the notice attached as Exhibit B (the "Notice") by U.S. Mail, First Class to the individuals identified on the list attached as Exhibit C, who are believed by the Parties to be the members of the Class, with the following understanding:
 - (1) the Notice will be mailed to the most recent address included in the file maintained by the Clerk of the State Court of Grady County with respect to each Class member's criminal case; and

- (2) if the Notice that is originally mailed is returned to Grady County with a forwarding address, Grady County will mail a second Notice to the forwarding address;
- (3) Grady County will inform the attorneys representing the Class of each Notice that is returned as undeliverable so that the attorneys for the Class will have an opportunity to identify a current address for each such Class member. If the attorneys for the Class identify a more current address, they shall provide that address to Grady County and Grady County shall mail another Notice to that address within five days of receipt of that address.

3. Each Notice mailed in accordance with paragraph 2, above, will be accompanied by a copy of the response form (the "Response Form") that is attached as Exhibit D. In addition, copies of the Response Form will be available in the Office of the Clerk of the State Court of Grady County. Furthermore, the attorneys for the Class and Grady County will deliver a copy of the Response Form by mail or electronic mail to any individual who requests such.

4. Subject to the terms of this Agreement, each individual who satisfies the criteria for Class membership will have the opportunity to opt out of the Class. Those individuals may opt out of the Class by indicating their intention to do so on the Response Form and returning that Response Form to the attorney for Defendant Grady County. The individuals who opt out of the Class will not be precluded from asserting any claim or lawsuit against Judge Bass or Grady County. However, the individuals who opt out of the Class will not be entitled to any of the compensation due to members of the Class pursuant to paragraph 7, below.

5. Each individual who satisfies the criteria for Class membership, and who does not opt out of the Class, will be entitled to the compensation described in paragraph 7, below. Further, if the Agreement receives final approval from the Court, each member of the Class will be precluded from asserting any claim or lawsuit against Judge Bass, Grady County, and their respective agents, officers, employees, officials and personal representatives as a result of the imposition, receipt or retention of Administrative Costs.

6. In order to receive any payment that he or she is entitled to pursuant to paragraph 7, below, a member of the Class must complete Section I of the Response Form and mail it to the attorney for Defendant Grady County within 90 days of the date that the Advertisement is published for the first time in accordance with paragraph 2(a), and that date is hereinafter referred to as the "Deadline."

7. Each member of the Class who mails a completed Response Form to the attorney for Grady County on or before the Deadline will be entitled to payment in the following amounts:

- a. \$100.00 for compensatory damages; and
- b. a payment equal to the amount of Administrative Costs paid by the member of the Class, not to exceed \$700.00.

8. Following the Deadline, the attorney for Grady County will:

- a. confirm that each individual who completed Section I of the Response Form and returned it to the attorney for Grady County on or before the Deadline is a member of the Class;

- b. verify the amount of Administrative Costs paid by each member of the Class who completed Section I of the Response Form and returned it to the attorney for Grady County on or before the Deadline;
- c. provide the attorneys for the Class with copies of all completed Response Forms.

9. Within 30 days after the date of the Deadline, the attorney for Grady County will determine the amount of money owed to each member of the Class who submitted a completed Response Form on or before the Deadline (the “Individual Payment Amount”), and the amount of money owed to the Class as a whole (the “Total Settlement Amount”), and the attorney for Grady County shall provide all documentation to the attorneys for the Class that shows the Individual Payment Amount due to each member of the Class and the Total Settlement Amount.

10. At the same time that the Parties ask the Court to certify the Class, as contemplated by paragraph 1, above, the Parties will ask the Court to: (a) give preliminarily approve the Agreement; (b) direct that the Class members be notified in accordance with the terms of the Agreement; and (c) schedule a fairness hearing in accordance with Rule 23(e)(2) of the Federal Rules of Civil Procedure.

11. Assuming that the Court grants the motion contemplated in the preceding paragraph, and the Court conducts a fairness hearing and, thereafter, finally approves the Agreement, a check for the Total Settlement Amount will be mailed to the attorneys for the Class. That check will be made payable to the attorneys for the Class and shall be deposited in their trust account.

12. Within 15 days of their receipt of the check for the Total Settlement Amount, the attorneys for the Class will mail a check for the Individual Payment Amount to each member of

the Class who is entitled to payment. That check will be mailed to the address shown on the completed Claim Form submitted by each such member of the Class.

13. Assuming that the Court gives its final approval to the Agreement, a check made payable to Jones in the amount of \$5,000.00 (the "Jones Check") will be mailed to the attorneys for the Class.

14. Following Jones's execution of the Satisfaction, Release and Indemnity Agreement attached hereto as Exhibit E, the attorneys for the Class will deliver the Jones Check to Jones.

15. If the Court enters an order giving its final approval to the Agreement, any member of the Class who has not requested to be excluded from the Class will be bound by all subsequent proceedings, orders and judgments of the Court and will be precluded from asserting any claim or lawsuit against Judge Bass, Grady County, and their respective agents, officers, employees, officials and personal representatives as a result of the imposition, receipt or retention of Administrative Costs.

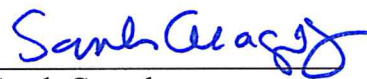
16. Assuming that it ultimately approves of the Agreement, the Court will enter an order that dismisses with prejudice all of the claims that the members of the Class may have against Judge Bass and Grady County with respect to the imposition of Administrative Costs.

17. Provided that the Agreement is ultimately approved by order of the Court, the Parties acknowledge and agree that the attorneys for the Class represent the prevailing party and they are entitled to submit a fee petition within 60 days of the entry of the Order Approving/Overseeing the Settlement. The parties further agree that Defendants' attorneys will have an opportunity to respond to that petition and, following that response and any reply brief from Plaintiffs, the Court will issue a ruling with respect to that petition.

18. If the Agreement is not approved by the Court, the Agreement shall become null and void and shall be without prejudice to the rights of the Parties, all of whom shall be restored to their respective positions existing immediately prior to the mediation held in the above-styled action (the "Lawsuit"). Further, if the Agreement is not approved by the Court, or if the Agreement is not otherwise consummated, for whatever reason, Grady County and Judge Bass shall have 10 days to file defensive pleadings in the Lawsuit and, if defensive pleadings are filed within that 10 day period, they shall be deemed to have been filed in a timely manner. In addition, the Parties agree that Jones will not seek a default in the Lawsuit prior to the expiration of that 10 day period.

19. The Parties agree that the Agreement incorporates a compromise and settlement of disputed claims, and the terms of the Agreement, including the payments called for the by Agreement, are not to be construed as an admission of liability on the part of Judge Bass or Grady County, both of whom expressly deny any liability.

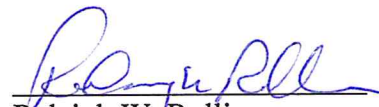

**NOTICE OF CLASS ACTION, PROPOSED SETTLEMENT
AND FINAL APPROVAL/FAIRNESS HEARING**

TO: INDIVIDUALS WHO HAVE APPEARED IN GRADY STATE COURT

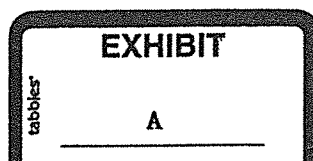
Please Read This Notice Carefully In Its Entirety. Your Right To Bring A Separate Lawsuit May Be Affected By The Settlement Of This Lawsuit. Your Rights And Options - And The Deadlines To Exercise Them - Are Explained In This Notice.

I. THE LAWSUIT

This lawsuit is currently pending in the United States District Court for the Middle District of Georgia ("the Court"). The lawsuit was brought by Roberta Imogene Jones (the "Representative Plaintiff") as a proposed class action against Grady County, Georgia ("Grady County") and Judge J. William Bass, Sr. ("Judge Bass"), who served as the Judge of the State Court of Grady County.

In her complaint, the Representative Plaintiff alleges that Judge Bass unlawfully imposed Administrative Costs upon individuals who appeared before him in criminal cases, and that Grady County wrongfully received and retained payments that were made in connection with the imposition of Administrative Costs.

Judge Bass and Grady County deny all of the claims made by the Representative Plaintiff. Judge Bass and Grady County also deny any wrongdoing or liability to the Representative Plaintiff or to any members of the proposed class (the "Class"). Judge Bass and Grady County contend that the Representative Plaintiff's claims have no merit, that they have meritorious defenses to the Representative Plaintiff's claims, and that they would prevail in the lawsuit if it were to proceed.



As a result of arms-length negotiations, a proposed settlement has been reached on the Representative Plaintiff's claims as well as the claims of the proposed Class. The settlement requires approval by the Court, and this notice advises you of the proposed settlement so that you can consider your legal rights.

The parties arrived at this settlement before any of the claims or defenses were tried on the merits and before the Court determined class certification. Accordingly, there has been no finding that Judge Bass or Grady County violated any law in their conduct toward the Representative Plaintiff or other members of the proposed Class. This Settlement is a compromise of disputed claims and is not an indication of liability of any sort. Neither the settlement nor this Notice should be construed as an admission or concession of liability by Judge Bass or Grady County.

Counsel for the Representative Plaintiff and the Class ("Class Counsel") have investigated the facts and the applicable law regarding the matters raised in the lawsuit. The issues before the Court are complex and there is uncertainty as to the outcome of the lawsuit. Class Counsel believe that the claims raised in the lawsuit have merit, but recognize that there is a risk that Judge Bass and Grady County may prevail. Therefore, on November __, 2014, Class Counsel entered into a settlement agreement (the "Settlement Agreement") with Judge Bass and Grady County. The Settlement Agreement has been preliminarily approved by the Court and, if it is finally approved by the Court, the Settlement Agreement will fully and finally resolve the claims asserted by the Representative Plaintiff against Judge Bass and Grady County, on behalf of herself and anyone else in the Class.

II. CLASS ACTION

The parties have agreed and the Court has ordered that, for settlement purposes only, the lawsuit may be maintained as a class action, subject to final and permanent approval at the conclusion of the settlement process. If this proposed settlement is not finally approved, or is withdrawn at any time, for any reason, the parties have agreed that the lawsuit will return to the same status as before the parties entered into the Settlement Agreement.

IV. THE PROPOSED SETTLEMENT

If it is finally approved, the Settlement Agreement will result in the dismissal of the lawsuit with prejudice and the release of those claims that were or could have been asserted by the Representative Plaintiff or any other Class Member against Judge Bass and Grady County in connection with the imposition, receipt and retention of Administrative Costs. The Settlement Agreement contains all of the terms of the settlement and is available for review at www.schr.org, and is available for inspection at the Office of the Clerk of the State Court of Grady County in Cairo, Georgia.

Certification of Settlement Class

The Court has entered an order that provides certification of the Class for settlement purposes. The Class consists of each individual who meets the following criteria:

- (a) the individual had a criminal case pending in the State Court of Grady County;
- (b) on or after September 24, 2011, Judge Bass entered an order in the individual's criminal case that required the individual to pay Administrative Costs; and
- (c) the individual paid some or all of the Administrative Costs ordered by Judge Bass.

Payment to Individual Class Members

Pursuant to the terms of the Settlement Agreement, each member of the Class may be entitled to receive: (1) a payment of \$100.00 as compensatory damages; and (2) a payment equal to the amount of Administrative Costs that he or she paid, not to exceed \$700.00. Thus, the maximum amount that any member of the Class may be entitled to receive is \$800.00.

Attorneys' Fees

Class Counsel have prosecuted this litigation without receiving any attorneys' fees to date. In addition, Class Counsel have advanced all of the costs necessary to prosecute this litigation. Class Counsel will ask the Court to award them fees and expenses to be paid by Judge Bass and Grady County. The amount of attorneys' fees and expenses awarded to Class Counsel will not impact the amount of money paid to members of the Class. The Court will conduct a hearing on the amount of attorneys' fees and expenses at a later date.

Class Representative Incentive Award

The Representative Plaintiff will be paid \$5,000.00 as compensation for her services as the Class Representatives in the lawsuit. The amount paid to the Representative Plaintiff will not impact the amount of money paid to the other members of the Class.

Entry of Final Judgment and Release

The Settlement Agreement is subject to final approval by the Court. If the settlement is approved, the members of the Class will be bound by the terms of the settlement and any order of the Court that finally approves the settlement and dismisses the lawsuit. If the settlement is approved, the Court will enter a judgment dismissing with prejudice all claims against Judge Bass and Grady County that arise from the imposition, receipt or retention of Administrative Costs. Under the terms of the Settlement Agreement, the members of the Class will release Judge Bass, Grady County, and their respective agents, officers, employees, officials, and personal representatives from any and all claims, demands, suits or causes of action of any nature or description as a result of the imposition, receipt or retention of Administrative Costs. The full text of this release is contained in the Settlement Agreement.

V. RIGHTS AND OPTIONS OF CLASS MEMBERS

If you are a member of the Class, you have the following options:

1. **Request the money due to you under the terms of the Agreement.** If you are a member of the Class and are entitled to compensation, and any money due to you under the terms of the Settlement Agreement will be mailed to you at the address that you provide. In order to receive your money, you must complete Section I of the form entitled "Response Form" and return that form to Raleigh Rollins at 411 Gordon Avenue in Thomasville, Georgia 31792, by _____.

Copies of the Response Form are available in the Office of the Clerk of the State Court of Grady County. In addition, Class Counsel and the attorney for Grady County will deliver a copy of a Response Form by mail or electronic mail to any individual who requests such.

As a Class Member, you will receive any money due to you under the terms of the Settlement Agreement and be bound by any judgment or other final disposition of the lawsuit, including the release of claims and dismissal of the lawsuit with prejudice as provided in the Settlement Agreement. You will give up any and all legal and equitable rights you ever had, or now have, or hereafter may have against Judge Bass, Grady County, and their respective agents, officers, employees, officials and personal representatives as a result of the imposition, receipt or retention of Administrative Costs.

2. **Exclude Yourself from the Class.** You may request exclusion and "opt-out" of the Class. If you elect to be excluded from the Class, you will not be bound by any judgment or settlement of the lawsuit, nor will you receive any of the benefits of the class action, including

the payment to you of any money. You will retain, and be free to pursue, any claims that you may have on your own behalf.

In order to be excluded from the Class, you must complete Section II of the Response Form and return that form to Raleigh Rollins at 411 Gordon Avenue in Thomasville, Georgia 31792, by _____.

Copies of the Response Form are available in the Office of the Clerk of the State Court of Grady County. In addition, Class Counsel and the attorney for Grady County will deliver a copy of a Response Form by mail or electronic mail to any individual who requests such.

3. **Object to the Settlement Agreement.** Even if you are a member of the Class, you may file an objection to the Settlement Agreement, and/or voice your objection, by yourself or through counsel, at the final approval hearing to be held in this case.

If you wish to file an objection to the Settlement Agreement, you must do so within ninety (90) days of the date of this Notice, by filing a letter with the Clerk of the United States District Court for the Middle District of Georgia at 201 W. Broad Street in Albany, Georgia 31701. The letter should reference this lawsuit and include: (i) a statement of each objection being made; (ii) a detailed description of the legal authorities underlying each such objection; (iii) a statement of whether the objector intends to appear at the Final Approval/Fairness Hearing; (iv) a list of witnesses who the objector may call by live testimony, oral deposition testimony, or affidavit during the Final Approval/Fairness Hearing; and (v) a list of the exhibits that the objector may offer during the Final Approval/Fairness Hearing, along with copies of those exhibits. Any Class member who does not file an objection within the time and in the manner described above will be forever prohibited from raising any objection to such matters in the event that the settlement is approved.

4. **Enter an Appearance or Intervene.** Even if you are a member of the Class, you may enter an appearance in the lawsuit through an attorney if you so desire or seek to intervene in the lawsuit. Any request for intervention must be by motion and must comply with the Federal Rules of Civil Procedure. All entries of appearance or motions to intervene must be made within ninety (90) days of the date of this Notice. Any Class Member who does not file a request for intervention within the time and in the manner described above is forever prohibited from seeking intervention in this lawsuit.

VI. FINAL APPROVAL HEARING

A final approval hearing will be held by the Honorable W. Louis Sands at _____ a.m./p.m. on _____, 2015, at the C.B. King Courthouse at 201 W. Broad Street in Albany, Georgia, to determine: (1) whether the lawsuit should be finally certified as a class action for the purposes of settlement; (2) whether the Settlement Agreement should be finally approved as fair, reasonable and adequate; and (3) the validity of any properly filed Objections.

MEMBERS OF THE CLASS WHO DO NOT OBJECT TO THE SETTLEMENT OR ANY OTHER MATTER TO BE CONSIDERED AT THE FINAL APPROVAL HEARING NEED NOT ATTEND THE FINAL APPROVAL HEARING.

VII. SCOPE OF SETTLEMENT PROPOSAL

If the settlement is approved, the terms of the Settlement Agreement, including the release outlined in Section IV of this Notice, will be final and binding upon, and shall inure to the benefit of: (a) all Class Members, except those who request timely and proper exclusion from the Class; (b) any present, former, and future spouse, heir, executor, administrator, representative, agent, attorney, partner, successor, predecessor-in-interest, assignee, employee, insurer or other party standing in the shoes of any member of the Class; (c) Judge Bass, Grady County, and their respective agents, officers, employees, officials and personal representatives; and (d) the Association of County Commissioners of Georgia – Interlocal Risk Management Agency.

VIII. FOR MORE INFORMATION

If you have any questions concerning the matters dealt with in this Notice, please direct your inquiries in writing to Class Counsel at the address listed above in Section III of this Notice.

IX. PLEADINGS AND OTHER RECORDS

NOTICE OF CLASS ACTION, PROPOSED SETTLEMENT
AND FINAL APPROVAL/FAIRNESS HEARING

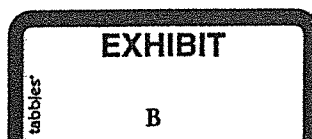
The above-referenced lawsuit was filed as a proposed class action against Grady County, Georgia, and Judge J. William Bass, Sr. ("Judge Bass"), who serves as Judge of the State Court of Grady County. The lawsuit alleges that Judge Bass unlawfully imposed Administrative Costs on certain defendants that appeared before him, and that Grady County received and retained funds as a result of the payment of Administrative Costs. Judge Bass and Grady County deny that they have engaged in any unlawful or wrongful conduct.

The Court has entered an order certifying a class (the "Class") made up of individuals who meet the following criteria: (a) the individual had a criminal case pending in the State Court of Grady County; (b) on or after September 24, 2011, Judge Bass entered an order in the individual's criminal case that required the payment of Administrative Costs; and (c) the individual paid some or all of those Administrative Costs.

Records show that you may be a member of the Class and, for that reason, you may be entitled to receive a payment pursuant to the terms of a settlement agreement that has been reached with respect to the lawsuit. The settlement agreement is available for review at www.schr.org, and is available for inspection at the Office of the Clerk of the State Court of Grady County in Cairo, Georgia.

The settlement agreement provides that each member of the Class may be entitled to receive: (1) a payment of \$100.00 for compensatory damages; and (2) a payment equal to the amount of the Administrative Cost that he or she paid, not to exceed \$700.00.

In order to receive payment, each member of the Class must complete Section I of the Response Form that is attached hereto, and return that form to the following address by _____, 2015, which is the deadline to submit claims:

Assuming that you are a member of the class, a check for the amount of money that you may be entitled to receive will be mailed to you at the address shown on the Response Form. For that reason, it is very important that you include the address at which you receive mail and notify Raleigh Rollins of any subsequent change of address.

Please note that, if the Court gives its final approval to the settlement agreement, regardless of whether you submit a Response Form, and you are a member of the Class, you will be barred from filing any lawsuit against Judge Bass, Grady County, and their respective agents, officers, employees, officials and personal representatives as a result of the imposition, receipt or retention of Administrative Costs.

If you do not want to be bound by the terms of the settlement agreement, you may opt out of the Class by completing Section II of the Response Form and returning it to Raleigh Rollins at the address shown above by _____. If you opt out of the Class, you will not be prohibited from asserting any claims that you may have against Judge Bass or Grady County, however, you will not receive any payment to which you may be entitled under the terms of the settlement agreement.

Even if you are a member of the Class, you may object to the terms of the settlement agreement by filing a written objection in the above-referenced lawsuit by _____. Any such objection should be mailed to the Clerk of the United States District Court, whose address is 201 W. Broad Street, Albany, GA 31701. In addition, the Honorable W. Louis Sands will conduct a fairness hearing with respect to the terms of the settlement at ____ p.m. on _____ in the C.B. King Courthouse, which is located at 201 W. Broad Street in Albany, Georgia, and you may appear at that hearing and voice any objection that you have to the settlement agreement.

Finally, even if you are a member of the Class, you may enter an appearance in the lawsuit through an attorney if you so desire or seek to intervene in the lawsuit. Any request for intervention must be made by motion and must comply with the Federal Rules of Civil Procedure. All entries of appearance and motions to intervene must be filed by _____, 2014. Any Class Member who does not file a request for intervention in the time and manner described above is forever prohibited from seeking intervention in this lawsuit.

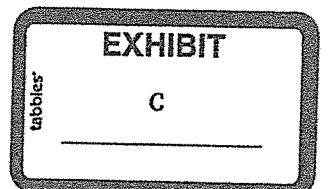

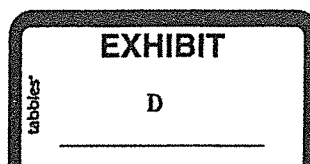

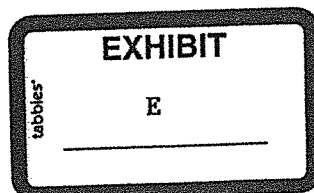

RECITALS

- A. ROBERTA IMOGENE JONES ("Plaintiff") filed a complaint against GRADY COUNTY, GEORGIA ("Grady County") and JUDGE J. WILLIAM BASS, SR. ("Judge Bass"), individually and in his official capacity as Judge of the State Court of Grady County, in the United States District Court for the Middle District of Georgia, bearing Civil Action File Number 1:13-cv-156(WLS) (the "Lawsuit") arising out of an order (the "Order") that Judge Bass entered in a criminal case that required Plaintiff to pay administrative costs ("Administrative Costs") in the amount of \$700.00, Plaintiff's payment of those Administrative Costs, and Grady County's receipt and retention of Plaintiff's payment(s).
- B. In the complaint that she filed in the Lawsuit, Plaintiff sought the certification of a class consisting of all persons who have paid Administrative Costs (the "Class") and the Court subsequently certified the Class;
- C. Plaintiff, Grady County and Judge Bass (the "Parties") have agreed to settle the claims that Plaintiff is asserting in the Lawsuit, as well as the claims that are being asserted in the Lawsuit on behalf of the Class;

In consideration of the payment called for herein, Plaintiff completely releases and forever discharges Grady County; Judge Bass, individually and in his official capacity as Judge of the State Court of Grady County; the Association of County Commissioners of Georgia-Interlocal Risk Management Agency ("ACCG"), and their respective agents, employees, servants, attorneys, elected officials, appointed officials, heirs, executors, administrators, personal representatives, successors and assigns (hereinafter referred to collectively as "Releasees") from any and all claims, demands, obligations, actions, and causes of action of any type, whether based in tort, contract, breach of warranty, strict liability, statute, or any other theory of recovery, including, but not limited to, those based on violations of constitutional rights or immunities, which Plaintiff now has or which may hereafter accrue or otherwise be acquired on account of the Order, the imposition of Administrative Costs upon Plaintiff, Plaintiff's payment of Administrative Costs, Grady County's receipt and retention of Plaintiff's payment(s), or any other alleged act or omission that gave rise to the Lawsuit, including, but not limited to, claims seeking to recover for: (1) any violation of the right to due process afforded Plaintiff by the Constitution of the United States (the "Constitution") or the Constitution of the State of Georgia (the "Georgia Constitution"); (2) any taking of Plaintiff's property in violation of the Constitution or the Georgia Constitution; (3) any conversion of Plaintiff's property;

(4) any unjust enrichment enjoyed by Releasees, or any one of them; and (5) money had and received.

2. Payment

In consideration of the General Release and Discharge set forth in paragraph 1, above, and other agreements in this General Release, ACCG agrees to pay and Plaintiff agrees to accept the sum of FIVE THOUSAND DOLLARS (\$5,000.00) payable to Plaintiff and her attorneys, the Southern Center for Human Rights.

3. Attorney's Fees, Costs and Dismissal with Prejudice

The Parties acknowledge and agree that, pursuant to the terms of the Settlement Agreement, the attorneys for Plaintiff are entitled to file a fee petition in the Lawsuit. The Parties further agree that the Court will issue an order, which the Parties may appeal, with respect to that petition and the only attorneys' fees that Releasees, or any one of them, will be required to pay to the attorneys representing Plaintiff and the Class will be set forth in the order issued by the Court. Thus, other than the filing of the fee petition referred to above, Plaintiff is hereby releasing any claim for attorneys' fees that she has or may have against Releasees, or any one of them. Furthermore, Plaintiff will cause her attorneys to do whatever is necessary to ensure that the Lawsuit is dismissed with prejudice in accordance with the terms of the Settlement Agreement.

4. No Reliance on Representations by Released Parties

Plaintiff assumes the risk of any and all claims for damages which exist as of this date, or that may exist in the future, but of which she does not know or suspect to exist, whether through ignorance, oversight, error, negligence, or otherwise, and which, if known, would materially effect the decision to enter into this General Release. Plaintiff is entering into this General Release voluntarily and with advice of counsel of her own choosing, and not in reliance on representations made by Releasees.

5. No Admission of Liability or Fault

This General Release incorporates a compromise and settlement of disputed claims, and the payment made hereunder is not to be construed as an admission of liability on the part of Releasees, who expressly deny any liability. This payment and the compromise and settlement are made and entered into to end the cost, burden and uncertainty of further litigation and to allow Releasees to buy their peace.

6. Entire Agreement and Successors in Interest

The Settlement Agreement and this General Release contain the entire understanding between the Parties with regard to the matters set forth herein and shall be binding upon and inure to the benefit of the executors, administrators, personal representatives, heirs, successors and assigns of each. No other promises or agreements have been made to procure the Settlement Agreement and this General Release.

7. Outstanding Expenses

In consideration of the payment made hereunder, Plaintiff represents that all medical expenses, including doctor, hospital, drug, psychologist, psychiatrist, counselor, and all other medical bills alleged to have been incurred as a result of the Order, the imposition of Administrative Costs upon Plaintiff, Plaintiff's payment of Administrative Costs, Grady County's receipt and retention of Plaintiff's payment(s), or any other act or omission giving rise to the Lawsuit, have been paid or will be paid by her out of the Settlement Proceeds, or otherwise. Plaintiff further represents that there are no medical expenses, liens, or claims for which Releasees, or any one of them, may be held liable under Medicare, Medicaid, CHAMPUS, CHAMPVA, TRICARE, ERISA or under any other law or statute of any state or the United States of America, or as a result of any such claim by any agent or authority thereof, or by any insurer or other entity that provided benefits to or on behalf of Plaintiff. Plaintiff further warrants and represents that there are no liens, claims or expenses of any other kind whatsoever against the Settlement Proceeds. Plaintiff further agrees to indemnify Releasees, and each one of them, against any liens, claims or expenses referred to herein pursuant to Paragraph 8, below.

8. Indemnity and Hold Harmless Agreement

The compromise and settlement set forth in this General Release shall include all claims arising out of any injury or damage to Plaintiff. Accordingly, and in further consideration for the payments made, Plaintiff agrees to indemnify and hold harmless Releasees of and from any loss, expense, claim, demand, action, cause of action, suit or judgment of any kind and description (including Releasees' attorneys' fees, costs and expenses, not only

in connection with defending against any such loss, expense, claim, demand, action, cause of action, suit or judgment, but also for the enforcement of any indemnity and hold harmless provision of this Agreement) which may have been or which may be presented hereafter against Releasees, or any one of them, by Plaintiff or by any other person or entity because of or in any manner arising from or by reason of, or which in the future might arise from or by reason of, the Order, the imposition of Administrative Costs upon Plaintiff, the payment of Administrative Costs by Plaintiff, Grady County's receipt and retention of Plaintiff's payment(s), or any injuries or damages that Plaintiff sustained, or claims to have sustained, as a result of such.

9. Prior Notice to Claimants of Lack of Insurer's Consent

Pursuant to O.C.G.A. § 33-7-12, Plaintiff is hereby notified of the lack of consent of Releasees (other than ACCG) to this compromise and settlement and of the fact that Releasees (other than ACCG) are not precluded from the further assertion of claims against Plaintiff.

10. Marital Status

Plaintiff represents and warrants that she was not married on the date on which the Order was entered and no person has any claim for loss of consortium as a result of injuries or damages that Plaintiff may have sustained in connection with the Order, the imposition of Administrative Costs upon Plaintiff, Plaintiff's payment of Administrative Costs, or Grady County's receipt and retention of Plaintiff's payment(s) and, pursuant to paragraph

8, above, Plaintiff agrees to indemnify Releasees from any action which may arise in this regard.

11. No Assignment

Plaintiff warrants and represents that she is the sole and rightful owner of all rights, title and interest in and to every claim that she asserted in or that she could have been asserted in the Complaint filed in the Lawsuit. Plaintiff further represents and warrants that, prior to the execution of this General Release, she did not assigned or transferred, whether by act or otherwise, any such claim to any other person or entity.

12. Representation

Plaintiff acknowledges that she is represented by legal counsel in these matters. Plaintiff further represents and warrants that she has had every opportunity to consult with her attorney; that her attorney has explained the meaning and intent of the wording of this General Release, and that she understands those matters. Plaintiff recognizes that her claims are disputed by Releasees. Under all the attendant facts and circumstances, Plaintiff has carefully evaluated whether she should settle the claims described herein and she is certain that she is acting in her own best interest in entering into this General Release. Plaintiff further acknowledges that she can read and write and is laboring under no disability and has been subject to no undue influence in entering into this General Release and executing this instrument.
