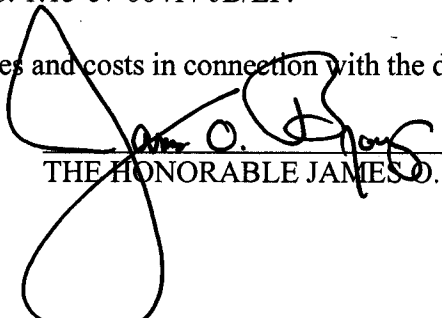
**ORDER OF PARTIAL DISMISSAL OF PLAINTIFF'S
