Defendant District of Columbia and the ten individual MPD officers who have been sued in this action (collectively, "Individual Defendants") have filed a <u>61</u> Motion to Dismiss that is ripe for this Court's review. The Court has considered the parties' submissions, and it finds that supplemental briefing regarding the issue of qualified immunity is necessary, because neither side has developed its qualified immunity arguments with enough specificity for this Court to decide the merits of Defendants' motion. Specifically, in the motion at issue, the Individual Defendants fail to specify whether they seek qualified immunity solely on the grounds that there was no constitutional violation, or whether they also maintain that the right was not clearly established at the time of any violation. <i>Cf. Patterson v. United States</i>, 999 F. Supp. 2d 300, 311 (D.D.C. 2013) ("As laid out by the Supreme Court, the two pertinent questions in determining whether qualified immunity applies are (1) whether a constitutional right would have been violated on the facts alleged, and (2) whether the right was clearly established at the time of the violation." (internal quotation marks and citations omitted)). Likewise, Plaintiffs merely assert that "broad, undeveloped assertions devoid of supporting authority cannot justify dismissal" (Pls.' Opp'n to Defs.' Mot. to Dismiss, ECF No. 65, at 6 n.2), and they do not otherwise respond to the Individual Defendants' qualified immunity arguments. <i>Cf. Kyle v. Bedlion</i>, No. 12-cv-1572, 2016 WL 1301043, at *4 (D.D.C. Apr. 1, 2016) ("A defendant bears the burden of raising the defense of qualified immunity in response to a claim brought under section 1983, and once the defense is asserted, the burden of proof then falls to the plaintiff to show that the official is not entitled to qualified immunity." (internal quotations marks and citations omitted)). Thus, while it appears the Individual Defendants have met their burden of raising the qualified immunity defense such that Plaintiffs now bear the burden of demonstrating why the individual defendants are not entitled to qualified immunity, the basis (or bases) upon which qualified immunity is sought have not been made clear, nor have Plaintiffs clearly articulated their arguments in opposition to that motion. Accordingly, it is hereby ORDERED that the parties shall file supplemental briefs that conform to the following specifications: first, on or before December 26, 2016, the Individual Defendants shall file a supplemental brief of no more than 15 pages that clarifies the basis (or bases) upon which they are entitled to qualified immunity. Second, on or before January 23, 2017, Plaintiffs shall file a supplemental brief of no more than 25 pages that responds to the Individual Defendants' qualified immunity arguments and explains why the Individual Defendants are not entitled to qualified immunity on the grounds claimed. Any reply to Plaintiffs' responsive brief shall be no more than 10 pages, and shall be filed on or before February 10, 2017.
