P. 16 allows a party to obtain a modification of a scheduling order "only for good cause and with the judge's consent." Fed. R. Civ. P. 16(b)(4). It is the movant's burden to establish good cause. <u>See Parker v. Columbia Pictures Indus.</u>, 204 F.3d 326, 340 (2d Cir. 2000); <u>Nairobi Holdings Ltd. v. Brown Bros. Harriman & Co.</u>, 02 Civ. 1230 (LMM), 2006 U.S. Dist. LEXIS 54171, at *9 (S.D.N.Y. Aug. 3, 2006). "Whether good cause exists turns on the diligence of the moving party." <u>Holmes v. Grubman</u>, 568 F.3d 329, 335 (2d Cir. 2009) (internal quotations and citations omitted). "With respect to a request to extend discovery, the moving party must show why it could not have completed the necessary discovery within the time frame established under the existing scheduling order." <u>Kintetsu World Express (USA), Inc. v. Johnson Controls Inc.</u>, 14 Civ. 4947 (KAM), 2015 U.S. Dist. LEXIS 169190, at *6 (E.D.N.Y. Dec. 17, 2015). As per the Court's 12/23/2015 Order, depositions of fact witnesses were to be noticed by 12/31/2015, depositions of expert witnesses were to be noticed by 1/22/2016, and all discovery, including depositions, was to be completed by 2/5/2016. Defendants noticed the five requested depositions on 1/29/2016. According to Defendants' counsel, notice was provided at such a late stage because: (1) deposition testimony of their own clients and witnesses provided a sudden need to depose the three fact witnesses; and (2) documents belatedly received via subpoena from third-parties

		provided a need to depose Plaintiff's two expert witnesses. Plaintiff counters that the three fact witnesses Defendants seek to depose were identified long ago in Plaintiff's Fed. R. Civ. P. 26(a) disclosures and that the documents just recently received by Defendants are irrelevant to the assertions made by their experts. Defendants have not shown good cause to allow them to belatedly depose the three fact witnesses. Plaintiff identified these three fact witnesses in its Fed. R. Civ. P. 26(a) disclosures and, to the extent deposition testimony from Defendants or witnesses on their behalf provided some type of amorphous reason to depose these three fact witnesses, Defendants' counsel otherwise knew, or should have known, of this information prior to said depositions. This Court, however, will credit Defendants' counsel's claim that the documents just recently received via subpoena had an effect on their decision to depose Plaintiff's experts, thus triggering good cause to extend the discovery schedule only in that regard. In light of the foregoing, Defendants may depose Plaintiff's two experts by or before 3/11/2016. The parties' briefing schedule, as previously Ordered by the Court on 12/23/2015, is modified as follows: opening summary judgment briefs, including the statement of material facts, must besubmitted to the party in opposition by 4/11/2016.
